Dupont, the said Sheriff of the Parish of Terrebonne, State aferesaid, in consideration of the premises and under and by virtue of the laws of this State in such cases made and provided, do hereby sell, cede, transfer, assign, set over and deliver unto the said Albert M. Dupont heirs and assigns, all of the property hereinabove described as purchased by Albert M. Dupont hereby vesting the said purchaser in and to all the rights and titles which the said Clement Naquin had in and to said property.

To have and to hold said property to the said purchaser, his heirs and assigns forever.

And the recorder and Conservator of Mortgages in and for the Parish of Terrebonne, State of Louisiana, is hereby authorized and directed to cancel and erase from the Mortgage Records of his office all mertgages, liens, privileges and encumbrances cited in his Certificate of Mortgages as bearing upon said property subsequent to the mortgage on which the writ in obedience to which this sale was made was based.
