WHEREAS, the building provided for, and constructed in accordance with, said House Joint Resolution No 554 of the Twenty-fourth (1953) Oklahoma Legislature has been completed

NOW, THEREFORE, pursuant to, and subject to the conditions prescribed in, House Joint Resolution No. 554 of the Twenty-fourth (1953) Oklahoma Legislature, the State of Oklahoma, acting by and through its State Board of Public Affairs, does hereby transfer and convey to the Interstate Oil Compact Commission created by and in the "Interstate Compact to Conserve Oil and Gas" entered into by the Governor of the State of Oklahoma and the representatives of certain other oil-producing states at Dallas, Texas, on the 16th day of February, 1935 (52 Oklahoma Statutes 1951 §§ 203 to 211), the surface rights only in and to the following-described land, to wit:

Block 2, State Capitol Addition to Oklahoma City, Oklahoma, located in Oklahoma County, State of Oklahoma, except the minerals therein and thereunder, including, but not limited to, oil and gas,

unto belonging. TO HAVE AND TO HOLD the same for so long as the building thereon, hereinabove mentioned, shall be used by said. Interstate Oil Compact Commission as a headquarters office building for said commission, and provided that, if the same shall be abandoned or cease to be used by the said Interstate Oil Compact Commission
